Open Forum: Abigail Strutzenberg, Traci Fisher, Sherry Fisher, Mick Guttau, Ann Vorthman and Ryan Avis all spoke during open forum regarding the proposed policies on anti-bullying, complaints, suspensions, and the release of legal files. Supt. Elwood reviewed the SPED contract that was presented from Tri-Center Community Schools. Moved by board member Funkhouser seconded by board member Myers to approve bills, SPED contracts and minutes of the previous meetings as presented. Ayes: Schnepel, Funkhouser, Myers and Graber.

Mr. Schoening submitted a request for an additional director to lead a second Middle School Jazz Band. Moved by board member Schnepel seconded by board member Graber to fund the one time position and approve Supt. Elwood to advertise and start the process to hire a second director. Moved by board member Funkhouser seconded by Guttau-Fox to authorize attorneys Nitzschke and Sapp to review the files that are transferred. Ayes: Unanimous. Moved by board member Guttau-Fox seconded by board member Schnepel to authorize current legal counsel to investigate into the files. Ayes: Unanimous.

Last month, Supt. Elwood provided information on a volunteer retirement incentive plan. He has talked with the staff that would be affected by the incentive plan. At this time they would like the board to delay the incentive plan for one or two years.

Principals Behrens, Kay and McNeal provided written updates for each of the schools.
