Supt. Elwood gave athletic complex and landscape updates and informed Board of change orders of \$65.00 for single ADA Accessibility and \$10,520 for relocating of transformer.

Motion by Funkhouser, seconded by Myers to approve purchase of benches and picnic tables in amount of \$3,790.74 from American Park and Recreation and motion carried unanimously.

Principals Larsen, Berens and Navara gave reports on summer custodial projects in buildings, upcoming SAI conference, upcoming dates for pictures, multi-cultural night, 6th grade orientation, Capturing Kids Hearts PD, soccer camp update, and projected enrollment numbers.

Supt. Elwood went over his goals for the upcoming years and went over Board Policies 700 series with the only change being to 712:11 where they needed to update the notification system to match with our new technologies.

Motion by Hempel, seconded by Funkhouser to approve open enrollments of eleven students (kdg-1, 5th-2, 6ht-1, 7th-1, 8th-1, 9th-2, 10th-1, 11th-1, 12th-1 and motion carried unanimously.

Supt. Elwood gave security improvement updates, welcome back activities update, and the following dates: School Board Election – Sept. 10th, Sept. 9th and Oct. 14th as the next Board Meetings.
