- Motion by Mr. Stogdill and seconded by Ms. Olson to approve the consent agenda as presented Vote 4-0 Motion Passes
- Reports and Communication Items
 - Facilities and Summer Projects Report - This summer's projects focused on refreshing facilities and boosting efficiency. Major upgrades included LED lighting and new scoreboards, an elementary restroom remodel, expanded HVAC controls with room-level thermostats, and concrete/parking lot repairs that uncovered drainage issues. Together, these improvements brighten spaces, reduce maintenance costs, and strengthen building operations.
 - Weight room and Summer Conditioning Report - Students in the summer conditioning program saw strong performance gains in strength and speed, while injury data showed that low-attendance athletes were more prone to soft-tissue injuries. The report highlights the importance of consistent participation for both improved results and injury prevention
 - ELA and Science Curriculum Pilots Report - Elementary teachers are piloting CKLA by Amplify, while secondary science staff are testing NGSS-aligned programs in biology, chemistry, and physics, with feedback and assessments guiding adoption decisions later this year.
 - Elementary School Report - Elementary highlights include strong ISASP results, new state math intervention compliance, launch of CHAMPS and PLC Plus training, and engaging student activities around Homecoming.
 - MS/HS School Report - Treynor MS/HS celebrated top national recognition, strong student credit attainment, and early athletic successes across cross-country, volleyball, and football.

- Directors Report - Directors' updates highlighted heavy fall reporting, facility and nutrition audits underway, smooth transportation start-up with new preschool partnerships, and continued focus on operational readiness.

- Legislative Priorities - The board set four 2025 legislative priorities—full-day preschool, mental health supports, SSA with recruitment/retention, and transportation for open enrollment—while aligning with broader SAI priorities.
 - Motion by Ms. Olson and seconded by Mr. Christensen to have the following: Fund full day preschool, Mental Health Supports, Supplemental State Aid with Emphasis on recruitment and retainment, as our legislative priorities Vote: 4-0 Motion Passes
 - Insurance Renewal - Property, Work Comp., Etc.

 - Deductible is 1% which could be roughly \$740,000 on an estimated \$74,000,000 in property
- Motion by Ms. Olson and seconded by Mr. Stogdill to renew our insurance with EMC through Campbell Insurance in the amount of \$321,852.00 Vote 4-0 Motion passes

 - Project costs will be covered through the donations of an anonymous donor by using the Treynor School Foundation.
