Good News

- Girls Cross Country – 2025 State Champions (Class 2A): Team recognized with certificates. Coach Heather Yocum introduced athletes and shared season highlights including off-season preparation, pack running strategy, and consistent top finishes. Athletes shared memories from the home meet and the state finish.
- National Merit Commended Scholar: Claire recognized for commendation based on PSAT/NMSQT results.
- Football – District Champions, Postseason Honors: Season recap with 11 first-team all-district selections and additional second team and honorable mentions. Student representative shared reflections on team culture and achievement.
- Fall Musical: Student cast member reported on production effort, extended rehearsal timeline, choreography, costumes, and audience response.
- Volleyball: Season highlights reviewed, including individual milestones.
- College and Career Exploration: 8th graders visited Iowa Western; sophomores visited UNO; juniors visited Northwest Missouri State; visits to Iowa Pipe and Trade/HVAC Institute and Council Bluffs Police Department.
- Academic Recognition: U.S. News named Treynor Elementary and Middle School among “Best” schools for 2026. Continued strong performance on the Iowa School Performance Profile.

- MS/HS Report: Professional development focus on effective AI use in instruction; examples included formative assessment generation and historical “persona” interviews. Emphasis on quality prompting and responsible classroom use.

- Elementary Report: Weekly PD; implementation of Gradual Release Model with focus on independent practice; PLC+ deeper instructional conversations; BLT book study; 14 teachers in LETRS literacy training; Building Math Minds underway; voluntary book study "What Great Teachers Do Differently"; recent Walk of Fame events, annual rainbow photo, kindergarten fire truck rides.
 - Director's Report: Fall BEDS certified; West Gym lighting adjustments planned; voice evac panel at Elementary targeted for replacement; HVAC unit above 200s pods under review (bids approx. \$30,000 for compressor vs. \$130,000 for new unit); tabletop cyber scenario; successful federal transportation audit.
- Board Development Note: Brief monthly finance overviews suggested for new board members and refresher topics on school finance basics.

Pending certification of county canvass results, the Board plans a special meeting to swear in new members and conduct the Annual and Organizational Meetings together.

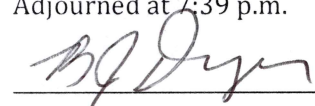
