 - Vote: The ayes were unanimous. The motion Carried.
3. Recognition of Visitors and Open Forum: No visitors signed up to speak.
4. Good News
 - School Board Recognition Month: May is recognized as School Board Recognition Month. The board members were acknowledged for their volunteer service and dedication, despite the challenges and lack of frequent thanks.
 - Raising the Red Sea Award: Cheri Klimek, a special education teacher in her first year at Treynor, received the Raising the Red Sea Award. She was nominated by a community member for her dedication, including helping with prom preparations and supporting a student transitioning back to the school system.
 - Treynor Schools Foundation: The foundation successfully raised \$10,000 through a matching grant, allowing for classroom grant applications. Eight grants were awarded, totaling \$3,540.03, to support various educational initiatives.
 - Awards and Achievements:
 - Mandy Vincent was named Iowa Nutrition Service Director of the Year.
 - The Band and Mixed Chorus received a Division I rating.
 - The Girls Soccer team achieved their 11th consecutive shutout.
 - Kelly Danker was recognized as the Iowa Governor's Scholar Award winner.
 - Student Activities:
 - The Elementary Arts Night showcased impressive student artwork.
 - Mock interviews were conducted for students.
 - The high school held its Night of the Arts.
 - The Battle of the Books involved middle school students, with a team named the Sassy Pineapples participating.
 - Athletic Achievements:
 - Brady Wallace became a Drake Relays champion in the 110 high hurdles, marking the first relay Drake champion in school history.
 - Riley Thomas will continue her running career at Simpson College.
 - Several school records were broken in track events, highlighting the success of the track program.

6. Reports and Communication Items
 - Invention Convention
 - The Invention Convention involved fourth graders who participated with six entries, and three of these advanced to the state level. Some notable inventions included:
 1. Cool Car Case: Designed to prevent the loss of jewelry and small items in cars, featuring a suction cup attachment for car windows.
 2. Sandwich Filler: A two-part syringe for convenient sandwich preparation, allowing for various fillings like peanut butter and jelly.
 - Students discussed the challenges they faced with their inventions and how they overcame them, such as securing hair ties and improving syringe functionality. Teamwork and reaching the state level were highlighted as favorite parts of the process. Taylor will advance to the National Invention Convention in Michigan on June 4th and 5th.
 - Student Representative Report – was presented by Monica, who highlighted several key points:
 - Experiences and Reflections: Monica and her fellow representative, Kyle, learned about the dedication and passion behind the scenes in the school district. They appreciated being the first students to hear about updates, such as the new football field.

- Suggestions for Improvement: They suggested continuing regular updates from student representatives and engaging with the student body for input. They also recommended exploring opportunities for student representatives to attend events and interact with peers in similar roles.
 - In-School Experiences: Beneficial experiences included the use of questions for learning targets, a challenging grading scale, and supportive classroom environments. Teachers were noted for their willingness to improve and work with students individually.
 - Future Suggestions: Students expressed a desire for semester finals to be scheduled before the holiday break, stricter harassment intervention, more recognition for certain extracurriculars, and encouragement for new opportunities.
 - Community and Support: Monica emphasized the supportive community and caring atmosphere at the school, which helps address any issues that arise.

 - Core Knowledge Language Arts Program:
 1. The literacy committee recommended piloting the CKLA program in the fall.
 - Night of the Arts:
 1. A successful event with 950 bowls of ice cream served, showcasing student artwork and performances.
 - CHAMPS Framework:
 1. Plans to implement the CHAMPS framework, a positive approach to behavior management, to ensure students know what is always expected of them.
 - Teacher Appreciation:
 1. Various activities and gestures were organized to show appreciation for teachers, including fun photo opportunities.

 1. Recognition of students of the month.
 2. Senior Decision Day celebrated students' post-high school plans, including attending four-year colleges, trade schools, two-year schools, and joining the military.

 1. Science department plans to pilot new materials, similar to the elementary's CKLA program pilot.

 - Preschool Survey
 - Survey Distribution: The survey was sent to approximately 150 families who showed interest in preschool and kindergarten enrollment.
 - Collaborations: Discussions are ongoing with St. Paul Church regarding potential preschool and before/after care programs. There is also an agreement with Zion Church for transportation services.
 - Enrollment Interest: Three families expressed interest in enrolling five-year-olds in preschool at a cost.
 - Upcoming Event: A preschool night is scheduled for Thursday, the 15th, to finalize enrollment numbers.
 - Transportation Clarifications: There are no restrictions for transportation from the school to St. Paul, and preschoolers do not need seatbelts for before and after care transportation. However, there are concerns about the appropriateness of long bus rides for young children, especially three-year-olds.
